Consignment Conditions & Agreement

- One Petticoat Lane LLC is an upscale consignment store of furniture, ladies clothing, jewelry and accessories; please only bring in items that meet this description for consignment.
- Ladies apparel, jewelry and accessories accepted Wednesday, Thursdays and Fridays from 10am– 6pm. No appointment is required.
- Home furnishings (excluding furniture) are accepted Wednesday, Thursdays and Fridays without an appointment. Furniture can be delivered only with a prior appointment
- Consignors will pay an annual fee of \$10 to consign an unlimited number of items.
- All pricing & periodic reductions will be established by One Petticoat Lane LLC. Once an item has sold, the consignor receives 40% of the selling price less any buyers' fee or sales tax or 50% for items selling over \$200.
- Consignor proceeds can be obtained during the first week of the month by coming to One Petticoat Lane LLC during any open business hours or be used as credit for in store purchases. Unclaimed consignor account balances more than one year old will automatically be forfeited to One Petticoat Lane LLC unless consignor has prior written agreement with One Petticoat Lane LLC.
- The consignment period is 60 days & begins once the item is on the sales floor. Items left after 60 days become the store's property and may be donated to charity. All holiday items will expire 5 days after their holiday regardless of when consigned.
- Consigned items later found unsuitable for sale (i.e. stains, holes, missing buttons, defects etc.) will automatically be donated to charity.
- We will strive to take great care of all articles consigned with us, but One Petticoat Lane LLC is not responsible for loss due to fire, theft or damages and everything is left at the owner's risk.

- All items must be current style or quality vintage and ready for resale (i.e. freshly laundered or dry-cleaned and free of holes, stains, odor wrinkles, pet hair etc.) Review of items is limited to 25 pieces per day. Any unaccepted items will be returned to you at time of drop off.
- Seasonal guidelines (dependent on weather and temperature)

Spring/SummerJanuary – JulyWinter/FallAugust – December

Unsold items <u>may not be reclaimed</u> and may be donated once the consignment period has expired.

We must see the item in order to guarantee absolute acceptance and arrive at an accurate price.
- Please bring help to unload your items. For liability reasons we will not provide assistance in moving items to be consigned.
- Furniture and home decor pieces may be claimed within the week prior to expiration. Furniture pickups will be accepted on Saturday and must have prior approval.
